The Notes will be consolidated and become fungible and form a single Series with the existing EUR 500,000,000 Series 1314 due 11 January 2028 issued on 11 January 2018, the EUR 750,000,000 Series 1355 due 11 January 2028 issued on 24 July 2018, the EUR 25,000,000 Series 1415 due 11 January 2028 issued on 6 June 2019, the EUR 25,000,000 Series 1423 due 11 January 2028 issued on 2 July 2019, the EUR 100,000,000 Series 1444 due 11 January 2028 issued on 8 October 2019, the EUR 50,000,000 Series 1686 due 11 January 2028 issued on 1 December 2023, the EUR 75,000,000 Series 1725 due 11 January 2028 issued on 3 June 2024 and the EUR 100,000,000 Series 1726 due 11 January 2028 issued on 3 June 2024 issued under the Programme (the "**Original Notes**").

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Notes in any member state of the European Economic Area (each, a "**Member State**") will be made pursuant to an exemption under the Prospectus Regulation from the requirement to publish a prospectus for offers of the Notes. Accordingly any person making or intending to make an offer in that Member State of the Notes may only do so in circumstances in which no obligation arises for the Issuer or the Dealer to publish a prospectus pursuant to Article 1 of the Prospectus Regulation or supplement a prospectus pursuant to Article 23 of the Prospectus Regulation, in each case, in relation to such offer. Neither the Issuer nor the Dealer has authorised, nor do they authorise, the making of any offer of Notes in any other circumstances.

This document constitutes the Final Terms of the Notes described herein for the purposes of Article 8 of the Prospectus Regulation and must be read in conjunction with the Base Prospectus in order to obtain all the relevant information, save in respect of the 2017 Terms and Conditions incorporated by reference therein. Full information on the Issuer and the Notes described herein is only available on the basis of a combination of these Final Terms and the Base Prospectus.
