The Notes will be consolidated and become fungible and form a single Series with the existing EUR 1,750,000,000 Series No. 1713 due 5 April 2029 issued on 5 April 2024, the EUR 50,000,000 Series No. 1737 due 5 April 2029 issued on 6 August 2024, the EUR 25,000,000 Series No. 1749 due 5 April 2029 issued on 16 October 2024, the EUR 100,000,000 Series No. 1763 due 5 April 2029 issued on 24 January 2025, the EUR 150,000,000 Series No. 1770 due 5 April 2029 issued on 12 February 2025 and the EUR 100,000,000 Series No. 1790 due 5 April 2029 issued on 3 April 2025 issued under the Programme (the "**Original Notes**").

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Notes in any member state of the European Economic Area (each, a "**Member State**") will be made pursuant to an exemption under the Prospectus Regulation from the requirement to publish a prospectus for offers of the Notes.
