The outlook for the global economy in the near- to medium-term remains uncertain due to several factors, including geopolitical risks, concerns around global growth and price and currency stability. Risks to growth and stability stem from, amongst other things, Brexit, imbalances in Europe



		<p>and elsewhere, and risks of rising protectionism. Furthermore, uncertainty about how economies will respond to the reduction of the quantitative easing programme of the European Central Bank ("ECB") that commenced in March 2015 and expected increases in interest rates by the U.S. Federal Reserve affect growth and stability.
